



2025 pricing changes for Domestic, USA and International Parcel Services

We are letting you know about upcoming pricing changes for our Parcel Services and our new flexible pricing structure that will enable you to access more competitive rates.

On June 26, 2025, we are implementing new rates for Parcel Services. This year, the weighted average price change is just under 1% for Domestic Parcels, 1.6% for International Parcel Services and -3% for USA Parcel Services. For parcels paid for in dealer and corporate outlets, the new rates will take effect on July 2, 2025.

We are also introducing a new parcels pricing structure that expands our rate codes for parcel services from 45 to 128. This means our rates will better reflect where you are shipping to and from – and you may see a decrease in high density lanes in major centres.

More competitive rates are just one way we are committed to improving your customer experience and better meeting your business needs.

The pricing changes will affect the following services:

The following is a summary of the key pricing changes that will come into effect in June, as well as information on this year's peak season surcharges:

Domestic Parcels

- The weighted average price increase for commercial customers using Domestic Parcel Services is 1%.
- We are introducing a new flexible pricing structure that is built to consider geography (local, regional, national), accessibility (urban and rural areas of the country), and distance (in-city shipping).
- The new pricing structure expands our rate codes for parcel services from 45 to 128 and enables customers to access more competitive rates.

USA/International

- The weighted average price change for commercial customers using USA Parcel Services is -3% (driven mostly by a substantial price decrease for Tracked Packet services)
- The weighted average price increase for commercial customers using International Parcel Services is 1.6%.
- We are introducing a new 750g price level for all USA and International Packet services to reduce the price gap between 500g and 1Kg.
- Additional rate codes are being implemented for Xpresspost – International and all International Packet services.

Options and Surcharges

- There will be no changes to rates for options and surcharges.
- The Peak Season surcharges for additional handling (for oversize / unpackaged items) and items that exceed Canada Post's specifications for size and weight (out-of-spec) will remain at 2023 prices and will be in effect from November 3, 2025 to January 11, 2026.
